

**SECOND AMENDMENT TO AGREEMENT
FOR POLICE SERVICES**

This Second Amendment is entered into on January 27, 2014, by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Dania Beach (the "CITY").

WHEREAS, on or about September 28, 2010, BSO and the CITY entered into an Agreement for Police Services; and

WHEREAS, on or about January 31, 2013, BSO and the CITY entered into a First Amendment to add one (1) Park Ranger position and to modify the consideration accordingly; and

WHEREAS, the initial Agreement and the First Amendment are hereinafter collectively referred to as the "Agreement"; and

WHEREAS, BSO and the CITY are now desirous of reducing the staffing, as set forth in Exhibit "A" of the Agreement, by one (1) Park Ranger position that was added to the staffing on February 1, 2013 but not filled; and


WHEREAS, the consideration will be reduced accordingly retroactive to February 1, 2013;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in this Amendment, the parties agree as follows:

1. Effective retroactive to February 1, 2013, the staffing structure shall be decreased by one (1) Park Ranger position and the consideration decreased accordingly, resulting in a Revised Exhibit "A", which is attached to and is incorporated into this Amendment by this reference.
2. Except as otherwise modified in this Amendment, the terms and conditions of the Agreement shall remain in full force and effect.


