

**FOURTH AMENDMENT**

**TO**

**AGREEMENT**

**POLICE SERVICES**

This Fourth Amendment is entered into this 1<sup>st</sup> day of October, 2014, by and between the Broward Sheriff's Office (hereinafter referred to as "BSO") and the City of Dania Beach, Florida (hereinafter referred to as the "CITY").

**WHEREAS**, on or about September 28, 2010, BSO and the CITY entered into an Agreement for Police Services; and

**WHEREAS**, on or about January 31, 2013, BSO and the CITY entered into a First Amendment to add one (1) Park Ranger position and modify the consideration accordingly; and

**WHEREAS**, on or about January 27, 2014, BSO and the CITY entered into a Second Amendment to remove one (1) Park Ranger position and modify the consideration accordingly; and

**WHEREAS**, on or about January 27, 2014, BSO and the CITY entered into a Third Amendment to reduce staffing by one Deputy Sheriff and one Community Service Aide position and modify the consideration accordingly; and

**WHEREAS**, the initial agreement, First Amendment, Second Amendment, and the Third Amendment are hereinafter collectively referred to as the "Agreement"; and

**WHEREAS**, BSO and the CITY are now desirous of extending the term of the Agreement by one year;

**NOW, THEREFORE**, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. The term of the Agreement is extended through September 30, 2015.
2. Except as otherwise modified herein, the terms and conditions of the Agreement shall remain in full force and effect.
