

FIRST AMENDMENT TO THE AGREEMENT

THIS FIRST AMENDMENT made and entered into in Broward County, Florida, this 11 day of May, 2004, by and between the City of Parkland, a municipal corporation organized and existing under the laws of the State of Florida, which is a municipality located within the boundaries of Broward County, Florida (hereinafter referred to as CITY) and Kenneth C. Jenne, II, Sheriff of Broward County, Florida, its successors and assigns (hereinafter referred to as BSO).

WITNESSETH:

WHEREAS, on or about March 5, 2004, BSO and CITY entered into an Agreement for law enforcement services; and

WHEREAS, the parties are desirous of modifying the Agreement to recognize BSO's obligation to fund pension contributions for those BSO employees that elected to remain in the City Police Pension Plan;

THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. The following provision shall be added to Section 10.7 of the Agreement:


BSO shall pay the employer and employee contribution to the Parkland Police Pension Plan as long as any member of the Plan remains actively employed by BSO. The parties agree that any plan amendments designed to enhance benefit shall be paid for with Chapter 185 insurance premium tax rebates and will not increase BSO's liability.

2. Except as modified herein, all remaining terms and conditions of the Agreement shall remain in full force and effect.




A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, APPROVING A CONTRACT BETWEEN THE CITY OF PARKLAND AND THE BROWARD SHERIFF'S OFFICE (BSO) FOR PROVISION OF POLICE SERVICES BY BSO TO THE CITY OF PARKLAND.

WHEREAS, the City Commission of the City of Parkland has reviewed various options for providing police services to its citizens; and

WHEREAS, the City Commission has considered a proposal from Kenneth C. Jenne, II, Broward County Sheriff (BSO) for the provision of police services; and

WHEREAS, BSO has made a presentation to the police officers of the City of Parkland, who voted in favor of having BSO provide police services to the City of Parkland; and


