

SIXTH AMENDMENT TO LAW ENFORCEMENT SERVICE AGREEMENT
BY AND BETWEEN CITY OF PARKLAND AND
THE SHERIFF OF BROWARD COUNTY

THIS SIXTH AMENDMENT is made and entered into this 8 day of February, 2012, by and between the City of Parkland, a municipal corporation organized and existing under the laws of the State of Florida, which is a municipality located within the boundaries of Broward County, Florida (hereinafter referred to as CITY) and the Sheriff of Broward County, Florida, (hereinafter referred to as BSO).

W I T N E S S E T H:

WHEREAS, on or about March 5, 2004, the CITY contracted with BSO to provide law enforcement services to the CITY; and

WHEREAS, on or about May 11, 2004, BSO and the CITY entered into a First Amendment to said Agreement; and

WHEREAS, on or about June 30, 2008, BSO and the CITY entered into a Second Amendment to said Agreement; and

WHEREAS, on or about January 13, 2009, BSO and the CITY entered into a Third Amendment to provide for additional services; and

WHEREAS, on or about February 23, 2010, BSO and the City entered into a Fourth Amendment to add overtime funding; and

WHEREAS, on or about February 8, 2011, BSO and the City entered into a Fifth Amendment to add overtime funding; and

WHEREAS, the initial agreement, First Amendment, Second Amendment, Third Amendment, Fourth Amendment and Fifth Amendment are hereinafter collectively referred to as the "Agreement"; and

WHEREAS, the parties are desirous of effectuating a Sixth Amendment to the Agreement to amend the staffing structure by adding two (2) Deputy Sheriffs and eliminate one (1) Part-Time Civilian Code Enforcement Officer and adding overtime funding.

NOW, THEREFORE, be it agreed by and between the parties as follows:

1. The above referenced recitations are true and correct and made a part hereof.
2. Commencing October 1, 2011, the staffing structure as set forth in Article V of the Agreement will be increased by two (2) Deputy Sheriffs and decreased by one (1) Part-Time Civilian Code Enforcement Officer. The modified staffing structure as of October 1, 2011 will be as follows:

1	District Chief
1	Executive Officer / Lieutenant
4	Deputy Sheriff Sergeants
19	Deputy Sheriffs
3	Deputy Sheriff Detectives
5	School Resource Deputies /Deputy Sheriff
1	Full-Time Civilian Code Enforcement Officer
2	Community Service Aides
<u>1</u>	Administrative Specialists
37	Total employees

3. The annual consideration for fiscal year 2012 (October 1, 2011 – September 30 2012) shall be four million nine hundred ninety nine thousand two hundred sixty eight dollars (\$4,999,268.00), payable in twelve (12) equal monthly payments of four hundred sixteen thousand six hundred five and 66/100 dollars (\$416,605.66), which includes the adjustments for the additional two (2) Deputy Sheriffs and the deletion of one (1) Part-time Civilian Code Enforcement Officer pursuant to this Sixth Amendment.

4. In addition to the annual consideration set forth in Section 3 above, the CITY agrees to pay BSO an additional twenty five thousand dollars (\$25,000.00) for fiscal 2012 which will be used to cover the overtime hours for enhanced code enforcement coverage and community policing activities. This twenty five thousand dollars (\$25,000.00) will be paid in twelve (12) equal monthly payments of two thousand eighty three and 33/100 dollars (\$2,083.33), which will be added to the monthly payment of four hundred sixteen thousand six hundred five and 66/100 dollars (\$416.605.66) as set forth in Section 3 for a total monthly payment of four hundred eighteen thousand six hundred eighty eight and 99/100 dollars (\$418,688.99). It is understood and acknowledge that the twenty five thousand dollars (\$25,000.00) for overtime as set forth herein is not be added to the base consideration for future years.


5. Except as herein amended, all other provision of the Agreement shall remain in full force and effect.
