**RESOLUTION NO. 2014-97**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA TO AUTHORIZE THE APPROPRIATE CITY OFFICIALS TO EXECUTE THE ATTACHED NINTH AMENDMENT TO THE AGREEMENT BY AND BETWEEN KENNETH C. JENNE, II, SHERIFF OF BROWARD COUNTY, FLORIDA AND CITY OF PARKLAND FOR LAW ENFORCEMENT SERVICES; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the City of Parkland ("City") reviewed various options for providing police services to its citizens; and

**WHEREAS**, on February 4, 2004, the City Commission awarded a contract with the Broward Sheriff's Office ("BSO") for law enforcement services ("Agreement"); and

**WHEREAS**, during the Fiscal Year 2014-2015 budget process, the City Commission authorized the addition of one (1) Deputy Sheriff and one (1) Code Enforcement Officer; and

**WHEREAS**, an Agreement amendment is necessary to reflect the correct listing of staffing levels and associated costs at the Parkland District based upon the City's newly adopted budget; and

**WHEREAS**, the City Commission hereby determines it to be in the best interest of the citizens and residents of the City of Parkland that the Ninth Amendment to the Agreement be adopted; and

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF PARKLAND, FLORIDA, THAT;**

**SECTION 1.** The foregoing "WHEREAS" clauses are confirmed and ratified as being true and correct and are hereby incorporate herein. All exhibits attached hereto are hereby incorporate herein.

**SECTION 2.** The City Commission of the City of Parkland hereby approves the Ninth Amendment to the Agreement By and Between Kenneth C. Jenne, II, Sheriff of Broward County, Florida and the City of Parkland for Law Enforcement Services to cover the: 1) Addition of one (1) Deputy Sheriff position; 2) Addition of one (1) Code Enforcement Officer; and 3) Correctly listing the staffing levels and associated costs at the Parkland District based upon the above mentioned changes, a copy of which is attached hereto and incorporated by reference as if set forth in full.

**NINTH AMENDMENT TO LAW ENFORCEMENT SERVICE AGREEMENT**  
**BY AND BETWEEN CITY OF PARKLAND AND**  
**THE SHERIFF OF BROWARD COUNTY**

THIS NINTH AMENDMENT is made and entered into this 1<sup>st</sup> day of October, 2014, by and between the City of Parkland, a municipal corporation organized and existing under the laws of the State of Florida, which is a municipality located within the boundaries of Broward County, Florida (hereinafter referred to as CITY) and the Sheriff of Broward County, Florida, (hereinafter referred to as BSO).

**W I T N E S S E T H:**

**WHEREAS**, on or about March 5, 2004, the CITY contracted with BSO to provide law enforcement services to the CITY; and

**WHEREAS**, on or about May 11, 2004, BSO and the CITY entered into a First Amendment to said Agreement; and

**WHEREAS**, on or about June 30, 2008, BSO and the CITY entered into a Second Amendment to said Agreement; and

**WHEREAS**, on or about January 13, 2009, BSO and the CITY entered into a Third Amendment to provide for additional services; and

**WHEREAS**, on or about January 20, 2010, BSO and the CITY entered into a Fourth Amendment to provide for additional services; and

**WHEREAS**, on or about November 10, 2010, BSO and the CITY entered into a Fifth Amendment to provide for additional services; and

**WHEREAS**, on or about October 19, 2011, BSO and the CITY entered into a Sixth Amendment to provide for additional services; and

**WHEREAS**, on or about November 14, 2012, BSO and the CITY entered into a Seventh Amendment to provide for additional services; and

**WHEREAS**, on or about September 18, 2013, BSO and the CITY entered into a Eighth Amendment to provide for additional services; and

**WHEREAS**, the initial agreement, First Amendment, Second Amendment, Third Amendment, Fourth Amendment, Fifth Amendment, Sixth Amendment, Seventh Amendment and Eighth Amendment are hereinafter collectively referred to as the "Agreement"; and

**WHEREAS**, the parties are desirous of effectuating a Ninth Amendment to the Agreement to add one (1) Deputy Sheriff and one (1) Code Enforcement Officer to the staffing structure effective October 1, 2014 and extend the term of the Agreement for one year.

**NOW, THEREFORE,** be it agreed by and between the parties as follows:

1. The above referenced recitations are true and correct and made a part hereof.
2. Commencing October 1, 2014, the staffing structure as set forth in Article V of the Agreement will be increased by one (1) Deputy Sheriff and one (1) Code Enforcement Officer, resulting in the following staffing structure:

1	District Captain
1	Executive Officer/Lieutenant
5	Deputy Sheriff Sergeants
23	Deputy Sheriffs
3	Deputy Sheriff Detectives
5	School Resource Deputies/Deputy Sheriff
2	Full- Time Civilian Code Enforcement Officer
2	Community Service Aides
1	Administrative Specialist

3. The annual consideration for Fiscal Year 2014 (October 1, 2014 - September 2015) shall include the consideration for the additional deputy sheriff and code enforcement officer from the date that they start working at the Parkland District.
4. The term of the Agreement is extended until September 30, 2015.
5. Except as herein amended, all other provisions of the Agreement shall remain in full force and effect.


