

**THIRD AMENDMENT**  
**TO LAW ENFORCEMENT SERVICE AGREEMENT**  
**BY AND BETWEEN**  
**THE CITY OF TAMARAC AND BROWARD SHERIFF'S OFFICE**

THIS THIRD AMENDMENT is made and entered into this 21<sup>st</sup> day of May, 2014 by and between the City of Tamarac, a municipal corporation organized and existing under the laws of the State of Florida, which municipality is fully located within the boundaries of Broward County, Florida (hereinafter referred to as "CITY") and the Broward Sheriff's Office (hereinafter referred to as "BSO").

**WITNESSETH:**

**WHEREAS**, on or about December 8, 2010, the CITY contracted with BSO to provide law enforcement services to the CITY ("Original Agreement"); and

**WHEREAS**, on or about November 14, 2012, the Parties entered into a First Amendment to add six personnel; and

**WHEREAS**, on or about September 25, 2013, the Parties entered into a Second Amendment to add two positions to handle the Red-Light Camera Program; and

**WHEREAS**, the CITY desires to amend the staffing structure by adding one (1) Community Service Aide; and

**NOW THEREFORE**, in consideration of the sums hereinafter set forth and for other good and valuable consideration, the receipt and legal sufficiency of which are hereby acknowledged, it is agreed as follows:

**Section 1.** The above recitals are true and correct and incorporated herein.

**Section 2.** Commencing on the date the position is filled, the staffing structure shall be increased by one (1) Community Service Aide with the Consideration increased accordingly to account for the additional staffing resulting in a revised Exhibit A, which is attached and incorporated herein.

**Section 3.** Except as amended herein, all other provisions of the Agreement, as amended, shall remain in full force and effect.

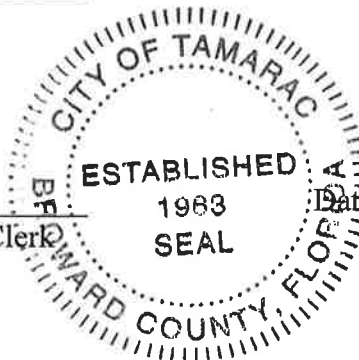
