l	ARTICLE 1 – PREAMBLE
2	This Agreement is entered into this day of day of 2014, by and between
4	the City of Lauderhill, Florida, (the "City") and the Broward County Police Benevolent
5	Association (the "PBA" or the "Union.")
6	WHEREAS, this Agreement reduces to writing the understandings of the City and
7	the PBA to comply with the requirements contained in Chapter 447, Florida Statutes, as
8	amended; and
9	WHEREAS, this Agreement is entered into to promote a harmonious relationship
10	between the City and the PBA and to encourage more effective employee service in the
11	public interest; and
12	WHEREAS, it is understood that the City is engaged in furnishing essential public
13	services which vitally affect the health, safety, comfort and general well being of the public

and the PBA recognizes the need to provide continuous and reliable service to the public;

herein contained, the parties agree as follows.

NOW THEREFORE, in consideration of the mutual covenants and agreements

### **ARTICLE 2 – RECOGNITION**

2 3	The City recogniz	es the PBA as the exclusive bargaining agent for the purpose of
4	collective bargainir	ng with respect to wages, hours and other conditions of employment for
5	those employees in	ncluded within the certified bargaining unit, and any other inclusions or
6	exclusions mutuall	y agreed to, in writing, by the parties, and approved by the Public
7	Employees Relation	ons Commission. The bargaining unit is defined by Florida Public
8	Employees Relatio	n Commission Certification Number 1819, which states as follows:
9	Included:	All full time sworn employees in the rank of police lieutenant.
10	Excluded:	Chief of police, assistant chief of police, police major, police
11		sergeant, police officer and all other employees of the City of
12		Lauderhill.

#### 2 3 3.1 This Agreement shall be effective upon ratification by the PBA and the City. 4 and shall continue until September 30, 2016. No portion of this Agreement 5 shall be retroactive. 6 3.2 In the event a new collective bargaining Agreement is not reached prior to 7 the expiration of this Agreement, the terms and conditions of this 8 Agreement shall be binding upon the parties until the ratification of a new collective bargaining Agreement, unless any specific term of this 9 Agreement indicates otherwise. 10

**ARTICLE 3 - TERM OF AGREEMENT** 

It is understood and agreed that this Agreement constitutes the total agreement between the parties. The term of this Agreement shall not be amended, except by the mutual written consent of the parties as they may from time to time agree.

This Agreement shall not be construed to deprive an employee of any benefit or protection granted by the laws of the State of Florida, or ordinance of the City of Lauderhill.

# **ARTICLE 4 - REPRESENTATION OF THE UNION**

2 3	4.1	The President of the PBA and/or the person or persons designated by
4		said President, shall have full authority to conclude an Agreement on
5		behalf of the Union, subject to a ratification vote of members of the
6		Bargaining Unit.
7	4.2	It is understood that the Union President and/or his or her designee is the
8		official representative of the Union for the purpose of negotiating with the
9		City.
10	4.3	Negotiations entered into with persons other than those as defined herein,
11		regardless of their position or association with the Union, shall be deemed
12		unauthorized and shall have no weight or authority in committing or in any
13		way obligating the Union.

## **ARTICLE 5 - REPRESENTATION OF THE CITY**

2		
3	5.1	The City shall be represented by the City Manager, or a person or persons
4		designated by the City Manager. The City Manager or his or her
5		designated representative(s) shall have full authority to conclude an
6		Agreement on behalf of the City, subject to ratification by an official
7		resolution of the City Commission.
8	5.2	It is understood that the designated representative(s) of the City are the
9		official representatives for the purpose of negotiating with the Union.
10	5.3	Any negotiations entered into with persons other that those defined herein,
11		regardless of their position or association with the City, shall be deemed
12		unauthorized and shall have no weight or authority in committing or in any
13		way obligating the City.
14

1		ARTICLE 6 - PBA ACTIVITIES
2 3	6.1	The PBA agrees that there shall be no solicitation for membership in the
4		PBA, signing up of members, collecting of any fees, dues or assessments
5		or meetings of the employee organization on City time.
6	6.2	With prior approval of the Chief or designee, on a case-by-case basis, the
7		PBA may distribute literature and hold Union meetings on City time.
8

### **ARTICLE 7 - NO STRIKE**

2 3	.7.1	"Strike" means the concerted failure to report for duty, the concerted
4		absence of employees from their positions, the concerted stoppage of work,
5		the concerted submission of resignations, the concerted abstinence in
6		whole or in part by any group of employees from the full and faithful
7		performance of their duties of employment with the City, participation in a
8		deliberate and concerted course of conduct which adversely affects the
9		services of the City, picketing or demonstrating in furtherance of a work
10		stoppage, either during the term of or after the expiration of a collective
11		bargaining agreement.
12	7.2	Neither the PBA, nor any of its officers, agents and members, nor any
13		employee organization members, covered by this Agreement, will instigate,
14		promote, sponsor, engage in, or condone any strike, sympathy strike,
15		slowdown, sick-out, concerted stoppage or work, illegal picketing, or any
16		other interruption of the operations of the City.
17	7.3	Each employee who holds a position with the PBA occupies a position of
18		special trust and responsibility in maintaining and bringing about
19		compliance with this Article and the strike prohibition in Section 447.505,
20		Florida Statutes and the Constitution of the State of Florida, Article 1,
21		Section 6. Accordingly, the PBA, its officers, stewards and other
22		representatives agree that it is their continuing obligation and responsibility
23		to maintain compliance with this Article and the law, including their
24		responsibility to abide by the provisions of this Article and the law by

1		remaining at work during any interruption which may be initiated by others;
2		and their responsibility, in event of breach of this Article or the law by other
3		employees and upon the request of the City, to encourage and direct
4		employees violating this Article or the law to return to work, and to disavow
5		the strike publicly.
6	7.4	Any or all employees who violate any provisions of the law prohibiting
7		strikes or of this Article may be dismissed or otherwise disciplined by the
8		City.
9	7.5	The City agrees to adhere to the provisions of Chapter 447, Florida
10		Statutes, regarding the prohibition on lockouts.

## ARTICLE 8 - DUES CHECK-OFF

		•
2 3	8.1	Any member of the PBA who has submitted a properly executed dues
4		deduction form (Appendix A) to the City Manager or his or her designee
5		may have his or her membership dues in the PBA deducted from his or her
6		wages. Dues deducted for wages of a member will be transmitted to the
7		PBA on a monthly basis. However, the City shall have no responsibility or
8		any liability for the improper deduction of dues.
9	8.2	The PBA shall indemnify, defend and hold the City harmless against any
10		and all claims, suits, orders, and judgments brought and issued against the
11		City as a result of any action taken or not taken by the City under the
12	•	provisions of this Article.

<del></del>		ARTIOLE 3 - I OLITICAL ACTIVITY
2 3	9.1	There shall be no discrimination against any employee covered by thi
4		Agreement by reason of political affiliation.
5	9.2	No employee covered by this Agreement shall, directly or indirectly, solicit o
6		take part in soliciting an assessment, subscription or contribution of any
7		employee of the City for any political organization or purpose during work
8		hours or on City property.

### **ARTICLE 10 - MANAGEMENT RIGHTS**

2 3	10.1	The City has and will continue to retain the unilateral right to operate and
	10.1	·
4		manage its affairs in all respects; and the powers or authority which the City
5		has not abridged, delegated or modified by the express provisions of this
6		Agreement are retained by the City. The rights of the City, through its
7		management officials, shall include, but shall not be limited to, the right:
8	10.1.	To manage and direct all employees of the City and the Police
9		Department and determine the standards and qualifications
10		therefore;
11	10.1.2	To hire, lay off, rehire, promote, transfer, schedule, assign and retain
12		employees in positions with the City;
13	10.1.3	To suspend, demote, discharge or take other disciplinary action
14		against employees for just cause;
15	10.1.4	To maintain the efficiency of the operations of the City and the Police
16		Department;
17	10.1.5	To determine the structure and organization of City government,
18		including the right to supervise, subcontract, expand, consolidate or
19		merge any department and to alter, combine, or reduce any division
20		thereof;
21		

1		10.1.6	To determine the number of all employees who shall be employed by
2			the City, the job make up, activities, assignments and the number of
3			hours and shifts to be worked per week including starting and
4			quitting time of all employees subject to the Article entitled Hours of
5			Work and Overtime;
6		10.1.7	To determine the number, types, and grades of positions or
7			employees assigned to an organizational unit, department or project,
8			and the right to alter, combine, reduce, expand, or cease any
9			position;
10		10.1.8	To determine internal security practices;
11		10.1.9	Control the use of equipment and property of the City;
12		10.1.10	Fill any job on an emergency basis;
13		10.1.11	Formulate and implement department policy, rules and regulations;
14			and
15		10.1.12	Introduce new or improved services, maintenance procedures,
16			materials, facilities and equipment, and to have complete authority to
17			exercise those rights and powers incidental thereto, including the
18			right to make unilateral changes when necessary.
19	10.2	If the	City fails to exercise any one or more of the above functions from time
20		to tim	e, it shall not be deemed a waiver of the City's right to exercise any or
21		all of	such functions.
22	10.3	Any ı	management rights, powers or privileges of the City not expressly
23		modif	ied or restricted by a specific provision of this Agreement shall remain

with the City and shall not be subject to the grievance or arbitration procedure contained herein. This provision shall not affect the Union's right to grieve and/or arbitrate the application of any of the above mentioned management rights.

#### **ARTICLE 11 - GRIEVANCE AND ARBITRATION PROCEDURE**

3 11.1

In a mutual effort to provide harmonious working relations between the parties to this Agreement, it is agreed to and understood by both parties that there shall be a procedure for the resolution of grievances between the parties arising from any alleged violation of the specific terms of this Agreement.

A grievance not advanced to the higher step within the time limits provided shall be deemed permanently withdrawn as having been settled on the basis of the decision most recently given. Failure on the part of the City to answer within the time limits set forth in any step will entitle the employee to

proceed to the next step.

13 11.3

Grievances shall be processed in the following manner.

STEP 1: Any aggrieved employee, with or without a PBA representative, shall file a written grievance with the employee's immediate supervisor within ten (10) calendar days of the occurrence or knowledge of the matter giving rise to the grievance. Such grievance shall be presented in writing, shall be signed by the employee and shall specify: (a) the date of the alleged grievance; (b) the specific article or articles and section or sections of this Agreement allegedly violated; (c) the facts pertaining to or giving rise to the alleged grievance; and (d) the relief requested. The employee's immediate supervisor may informally meet with the grievant to address the grievance. A Union representative may be

present at the meeting upon the grievant's request. The immediate supervisor shall reach a decision and communicate in writing to the aggrieved employee within ten (10) calendar days of receipt of the grievance.

STEP 2: If the grievance is not resolved at Step 1, or if no written disposition is made within the Step 1 time limits, he/she shall have the right to appeal the Step 1 decision to the Chief of Police or his/or her designee within ten (10) calendar days of the due date of the Step 1 response. Such appeal must be accompanied by a copy of the original written grievance, together with a signed request from the employee/Union requesting that the Step 1 decision be reversed or modified. The Chief of Police or his/her designee may conduct a meeting with the grievant and his/her representative, if needed. The Chief of Police or his/or her designee shall, within ten (10) calendar days after the presentation of the grievance (or such longer period of time as is mutually agreed upon in writing), render his/her decision on the grievance in writing.

STEP 3: If the grievance is not resolved at Step 2, or if no written disposition is made within the Step 2 time limits, he/she shall have the right to appeal the Step 2 decision to the City Manager or his or her designee within ten (10) calendar days of the due date of the issuance of the Step 2 decision. Such appeal must be accompanied by the filing of a copy of the original written grievance, together with a

request form signed by the employee/Union requesting that the Step 2 decision be reversed or modified. The City Manager or his/her designee may conduct a meeting with the grievant and his/her representative, if needed. The City Manager or his/her designee shall, within ten (10) calendar days (or such longer period of time as is mutually agreed upon in writing), render his/her decision in writing.

Where a grievance is general in nature in that it applies to a number of employees having the same issue to be decided, it shall be presented directly to the Chief of Police or his/her designee at Step 2 of the grievance procedure, within the time limit provided for the submission of the grievance in Step 1, and signed by the aggrieved employees or the PBA representative on their behalf.

In the event a grievance involving an issue of contract interpretation not involving discipline, or a disciplinary grievance involving a termination, demotion or suspension of three (3) or more working days has not been resolved at Step 3, the City or the PBA may submit the grievance to arbitration within ten (10) calendar days after the City Manager (or his designee) renders a written decision on the grievance, or the due date of that decision if no written decision is made. Disciplinary grievances involving suspensions of less than three (3) working days and written reprimands or other actions not involving the loss of pay shall not be arbitrable and the City Manager's decision at Step 3 as it relates to such grievances shall be final and binding.

The arbitrator may be any impartial person mutually agreed upon by the parties. In the event the parties are unable to agree upon said impartial arbitrator within ten (10) calendar days after the City or PBA request arbitration, the party demanding arbitration shall, within ten (10) calendar days of the date on which the parties reach impasse over the mutual selection of an arbitrator as set forth above, request a list of seven (7) names from the Federal Mediation and Conciliation Service. Within ten (10) calendar days of receipt of the list, the parties shall alternatively strike names, the City striking first. The remaining name shall act as the Arbitrator.

The City and the PBA shall mutually agree in writing as to the statement of the grievance to be arbitrated prior to the arbitration hearing, and the Arbitrator shall confine his/her decision to the particular grievance specified. In the event the parties fail to agree on the statement of the grievance to be submitted to the Arbitrator, the Arbitrator will confine his/her consideration and determination to the written statement of the grievance and the response of the other Party. Copies of any documentation provided to the Arbitrator by either party shall be simultaneously provided to the other party.

20 **11.8** 21 22 The Arbitrator shall have no authority to change, amend, add to, subtract from, or otherwise alter or supplement this Agreement or any part thereof or amendment thereto. The Arbitrator shall have no authority to consider

1		or rule upon any matter which is stated in this Agreement not to be subject
2		to arbitration.
3	11.9	Copies of the Arbitrator's decision shall be furnished to both parties within
4		twenty (20) days of the closing of the Arbitration hearing. The Arbitrator's
5		decision will be final and binding on the parties.
6	11.10	The Arbitrator may not issue declaratory or advisory opinions.
7	11.11	Unless otherwise agreed to by both parties, grievances under this
8		Agreement shall be processed separately and individually. Accordingly,
9		only one (1) grievance shall be submitted to an Arbitrator for decision in
10		any given case.
11	11.12	Each party shall bear the expense of its own witnesses and of its own
12		representatives for the purposes of the arbitration hearing. The impartial
13		Arbitrator's fee and any related expenses including any cost involved in
14		requesting a panel of arbitrators shall be paid by shared equally by each
15		party. The hearing room shall be supplied and designated by the City.
16		Any person desiring a transcript of the hearing shall bear the cost of such
17		transcript, unless both parties mutually agree to share such cost.
18	11.13	Settlement of grievances prior to the issuance of an arbitration award shall
19		not constitute a precedent or an admission that the Agreement has been
20		violated.
21	11.14	A probationary employee may not grieve any matter concerning
22		assignment, discipline or discharge.

1		ARTICLE 12 - POLICIES AND PERSONNEL RULES
2	12.1	The parties agree that the City may promulgate Personnel Policies and
3		Procedures and the General Orders issued by the Chief of Police
4		provided they do not conflict with the terms of this Agreement.
5	12.2	Any changes or additions to the Personnel Policies and Procedures
6		and/or the General Orders shall be copied to the PBA at least ten (10)
7		calendar days prior to their effective date. This ten (10) day period may be
8		waived by the PBA upon request of the City.
9	12.3	In the event of any conflict between the terms of this Agreement, the
10		General Orders, or the Personnel Policies, the following hierarchy in
11		application shall apply: the Agreement, the General Orders, Personnel
12		Policies and Procedures.
13		
14		

#### **ARTICLE 13 - PERSONNEL RECORDS** 2 13.1 3 The City agrees that all official personnel records shall be kept 4 confidential to the extent provided by law. 13.2 5 The City agrees that, with reasonable advance notice, a bargaining unit 6 employee shall have the right to inspect his/her official personnel file. 7 specifically excluding such records as those which are part of an ongoing 8 or active criminal or internal investigation. 13.3 The City shall provide bargaining unit employees with a copy of any 9 10 document placed in that employee's personnel file. 13.4 The City agrees that, after it completes an internal investigation 11 12 concerning a bargaining unit employee, it will provide that employee with a complete copy of the investigation file at no cost to the employee. 13 14 15 16

## **ARTICLE 14 - LEGAL REPRESENTATION**

2 3	14.1	Whenever a civil suit in tort is brought against an employee for injuries or
4		damages suffered as a result of any act, event, or omission of action
5		which is alleged to have occurred while the employee was on duty and
6		acting within the scope of his/her employment, the City will investigate the
7		circumstances to determine whether the employee acted in bad faith or
8		with malicious purpose or in a manner exhibiting wanton and willful
9		disregard of human rights, safety, or property.
10	14.2	If the City determines that the employee did not act in bad faith or with
11		malicious purpose or in a manner exhibiting wanton and willful disregard
12		of human rights, safety or property, the City shall undertake the defense
13		of the employee as required by law. Said defense shall cease upon
14		judicial finding, or finding by the City, that the employee acted in bad faith
15		or with malicious purpose or in a manner exhibiting wanton and willful
16		disregard of human rights, safety, or property.
17		
18		

1		ARTICLE 15 - HOURS OF WORK
2	15.1	Bargaining unit employees are salaried exempt employees under the Fair
3		Labor Standards Act. As such, they are paid a set salary regardless of
4		the number of hours/week that they work.
5		

#### **ARTICLE 16 - HOLIDAYS** 2 16.1 The City recognizes the following official holidays for employees covered 3 by this Agreement: 4 5 New Year's Day 6 President's Day 7 Memorial Day 8 Independence Day 9 Labor Day 10 Columbus Day Veteran's Day 11 12 Martin Luther King's Birthday 13 Thanksgiving Day 14 Day after Thanksgiving 15 Christmas Eve 16 Christmas Day 17 16.2 The method and circumstances of compensation for the above-18 designated holidays shall be governed by the City's Personnel Policies 19 20 and Procedures, unless modified by this Agreement. All members of the bargaining unit who work a Monday through Friday 16.3 21 schedule shall treat holidays falling Monday through Friday as normally 22 23 scheduled workdays.

Members who are required by the City to work on one of the above-designated holidays and who actually work on such holiday will receive premium pay at his/her regular straight time rate of pay for each hour the employee actually works on such holiday. For example, an employee who works an eight (8) hour shift on Thanksgiving will be entitled to 16 hours of pay for that day.

### **ARTICLE 18 - INSURANCE**

1

The City agrees to provide bargaining unit employees with medical and dental insurance on the same terms and conditions as are provided to other managerial employees of the City, as such may change from time to time.

#### **ARTICLE 19 - EDUCATION INCENTIVE AND TRAINING** 2 19.1 The City will pay incentive pay for education as defined by the Florida 3 Police Standard and Training Commission to all eligible employees 4 covered by this Agreement pursuant to the allowances provided by Florida 5 6 Statutes. In the event an employee is transferred or for any other reason 12 leaves the employ of the department, he/she shall return all uniforms and 13 equipment and City property to the department before the final paycheck 14 will be issued, otherwise the cost of said replacement shall be deducted 15 from the final check if sufficient, otherwise the employee shall be liable for 16 17 the deficiency. 18 19

Failure to timely respond shall automatically constitute a rejection. It is agreed that notice to the employee at the address last provided to

the City by the employee constitutes notice to the employee for the purpose of commencing the ten (10) day period. No new employee shall be hired in any classification until all employees on layoff status in that classification have had an opportunity to return to work; provided, however, that in the sole discretion of the City, such employees may be required to pass a medical or psychological examination in order to ensure that they are capable of performing the work available at the time of recall. No laid off employees shall retain recall rights beyond twelve (12) months from date of layoff.

#### 1 **ARTICLE 22 - SICK LEAVE** 2 3 22.1 Bargaining Unit Employees shall accrue 96 hours of sick leave/year (3.69 hours bi-weekly). Sick leave must be earned prior to use. 4 5 22.2 Bargaining Unit Employees are eligible for sick leave buy-back on the same 6 terms and conditions as other Managerial Employees of the City, as such 7 terms and conditions may be changed by the City from time to time. 22.3 8 If and when use of sick leave appears to be abused, or where an employee consistently uses sick leave as it is earned, the employee may be required 9 10 to furnish a doctor's note as proof of the necessity for such absence. The employer reserves the right to investigate all absences and require 11 employees to furnish a medical certificate. The employer also reserves the 12 right to require a sick employee to remain at home while off sick except 13 when seeing a physician or performing any other necessary task approved 14 first by the Department Head or designee. Any employee using sick leave 15 to care for a family member may leave home only if necessary to provide 16 17 care or transportation to immediate family members. 18 Abuse of sick leave or false claim of illness, injury or exposure to contagious diseases, or falsification of proof to justify sick leave shall 19 20 constitute grounds for disciplinary action and denial of sick leave pay. 22.4 Sick leave donation will be permitted in accordance with applicable Police 21 Department policy in effect upon ratification of this Agreement. In order to 22 receive donated sick leave, an employee must have exhausted all of his/her 23

### **ARTICLE 23 - ON-THE-JOB INJURY**

When an employee covered by this Agreement is compelled to be absent from duty because of an injury or illness determined to be compensable under the provisions of the Worker's Compensation Act, he/she shall be entitled to full pay less any benefit under the Worker's Compensation Act for a period of time not to exceed forty five (45) working days. The same time period may be extended based upon a review and recommendation by the Human Resources Director and the Police Chief with the approval of the City Manager, based upon the results of a medical examination. eligible for any extensions, the employee must, if directed by the City Manager, submit an application for disability retirement to the Pension Board or submit to a physical examination to determine the approximate length of time necessary to return to duty. The City Manager may, in his sole discretion, at any time during the extension, terminate such extension if he/she determines that the extension is no longer in the best interest of the City and the employee concerned. In that event, the employee, at the sole and exclusive discretion of the City Manager, may either be placed on unpaid leave status (after the employee is allowed to exhaust all accrued leave) or separated from employment. When so directed by the City, any employee out of work due to an

on-the-job injury shall present himself/herself for a medical examination.

The City will bear the full expense of said examination by a City appointed physician. The failure of such employee to present himself/herself for an

examination as directed will operate to automatically terminate any payments under this Article.

Whenever an employee out of work due to an on-the-job injury becomes physically able to perform some useful light duty work for the City, he/she may be required to do so as a condition to receiving the benefits specified in Section 1, above.

## **ARTICLE 24 - DRUG TESTING**

24.2 1 No drug testing will be conducted without the written approval of two 2 supervisory employees. Said approval shall indicate who is to be tested and why the test was ordered, including the specific objective fact 3 4 constituting reasonable suspicion. A copy of this document shall be 5 provided to the employee before the employee is tested. Without delaying the test, the officer will be offered an opportunity to explain 6 7 his/her behavior. If both supervisors continue to have "reasonable suspicion" the officer will be ordered to undergo testing. 8 24.3 9 In addition to the "reasonable suspicion" testing provided for above, the 10 City may institute a program of random drug testing utilizing a computer based program that will randomly select employees from the bargaining 11 unit with no greater frequency than on a monthly basis. No employee shall 12 13 be randomly tested in excess of 3 times in any calendar year. The City 14 shall notify the supervisor of each employee selected for random testing. The supervisor shall be responsible for ensuring that the employee is 15 16 immediately taken to the testing site. 24.4 Refusal to submit to drug testing pursuant to the procedures outlined in 17 18 this Article after being ordered to do so may result in disciplinary action, 19 up to and including termination. 20 24.5 The following procedures shall apply to the blood and urine tests 21 administered to employees:

- (A) The City may request urine and/or blood samples. The employee may, at his sole option and expense, upon request receive a blood test in addition to a urine test if none was ordered.
- (B) The test shall be performed at a reputable hospital or laboratory certified by the State of Florida as a medical laboratory, which complies with the scientific and technical guidelines for federal drug testing programs and the standards for certification of laboratories engaged in urine drug testing for federal agencies issued by the Alcohol, Drug Abuse and Mental Health Administration of the U.S. Department of Health and Human Services and comply with applicable Florida Statutes.
- (C) Urine and/or blood specimens shall be drawn or collected at a laboratory, hospital, doctor's office or medical facility. A union representative shall be allowed to accompany the employee, if requested, to the test and observe the collection of the specimen. If the City or the laboratory requires an observer when the urine specimen is given, the observer shall be of the same sex as the employee being tested. All specimen containers and vials shall be sealed with evidence tape, labeled and packaged if applicable, in the presence of the employee and the union representative, if available.
- (D) At the time the urine specimen or blood samples are collected, two samples shall be taken. In the event a urine specimen is tested as

positive under the drug testing screen, as specified below, a portion of that sample shall be subjected to gas chromatography/mass spectrophotometry [GC/MS testing]. If the GC/MS confirmation test also is positive, the employee may request a portion of the urine sample to be supplied to a qualified laboratory for independent analysis, the cost of which will be paid by employee. The failure of the Union or the employee to have a second test performed or present the results to the City shall not be used against the employee as a basis for discipline and shall not be introduced or referred to in any arbitration or appeal proceeding. After considering the results of the second test, if any, and any explanation offered by the employee, the City may take such disciplinary action utilizing the just cause standard pursuant to this agreement. Such disciplinary action may include referral to a substance abuse program or Employee Assistance Program for Assessment, counseling and referral for treatment and rehabilitation as appropriate.

- (E) The results of urine and blood tests performed hereunder will be held confidential to the extent permitted by law. Tests shall be performed for the presence of alcohol, non-prescribed controlled substances, chemical adulteration and/or narcotic drugs.
- (F) Tests shall be conducted using recognized technologies and recognized testing standards. Drugs, their metabolites, alcohol and

other substances for which the City will screen an employee's urine and/or blood sample include, but are not limited to the following: alcohol, amphetamines, barbiturates, benzodiazepines, cocaine metabolites (benzoylecogonine), marijuana metabolites (delta-9tetrahydro-cannabinol-9-carboxlyic acid), methagualone, opiates, and phencyclidine, and propoxyphene. All samples which test positive on a screening test shall be confirmed by gas chromatography/mass spectrophotometry [GC/MS]. **Employees** shall be required to document their legal drug and/or substance use, as required by the laboratory. Test results shall be treated with the same confidentiality as other medical records (except that they may be released to the City, the Union (if applicable) in any proceedings held regarding any disciplinary action on account of a positive drug test result, and to any proceedings held regarding any disciplinary action on account of a positive drug test result, and to any governmental agency). The affected employee must execute any required releases as a condition precedent to being able to challenge the City's compliance with this article and/or any aspect of the drug/alcohol testing procedure and/or results.

The standards to be used for employee drug testing of urine specimens are as follows:

An employee will be considered to test positive for alcohol at the level equal to or exceeding 0.04g% (blood specimen).

The levels used will be same as those set by the Federal Government CDL Program. As those levels change so will the levels in this Agreement. Levels found below those set above shall be determined as negative indicators. Tests for other non-presented controlled substances will be in accordance with federal government screening and confirmation standards.

- (G) The employee shall be presented with a copy of the laboratory report of all specimens which were tested.
- (H) At the conclusion of the drug testing, in the event a positive test is indicated and disciplinary action is taken, the employee may grieve such discipline through the contractual grievance arbitration procedure.

- (I) Employees who seek voluntary assistance for alcohol and substance abuse through the Employee Assistance Program prior to being ordered to take a drug and/or alcohol test, may not be disciplined for seeking such assistance. Request from employees for such assistance shall remain confidential to the employees or officers without the employee's consent. Employees enrolled in substance abuse programs as outpatients, shall be subject to all City rules, regulations and job performance standards.
- (J) Each step in the testing process shall be documented in writing to establish procedural integrity and to establish the chain of custody.

1		ARTICLE 25 - NON-DISCRIMINATION

Should any provision of this collective bargaining agreement, or any part thereof, be rendered or declared invalid by reason of any existing or subsequently enacted state or federal law, or by any decree of a court of competent jurisdiction, all other articles and sections of this Agreement shall remain in full force and effect for the duration of this Agreement. The parties agree to immediately meet and confer concerning any invalidated provision(s).

Except as specifically provided in this Agreement, neither party hereto shall be permitted to reopen or renegotiate this Agreement or any part hereof. This Agreement contains the entire agreement of the parties on all matters relative to wages, hours and terms and conditions of employment as well as all other matters which were or could have been negotiated prior to the execution of this Agreement.

#### **ARTICLE 27 – SUCCESSORS**

In the event the City transfers or assigns any of its facilities to another

political subdivision, and such transfer or assignment would result in the

layoff, furlough or termination of employees covered by this bargaining

agreement, the City shall attempt in good faith to arrange for the placement

of such employees with the new Employer. The City shall notify the Union

in writing at least sixty (60) days in advance of any such transfer or

In particular, should the Actual Rate of Return for any fiscal year be positive, the member's DROP account will be credited, as set forth herein, with interest equal to the Actual Rate of Return up to a cap of six percent (6%), with the remaining increase in the Actual Rate of Return above six percent (6%) credited to the Trust Fund. However, should the Actual Rate of Return for any fiscal year be negative, the Employee's DROP account will not decrease for that year. In a member's first and last year in the DROP and the first year following implementation of this provision for members already in the DROP, the Actual Rate of Return shall be prorated. Members shall not have the option of receiving a fixed amount in their DROP account for any period after ratification of this Agreement. In the event that the bargaining unit consisting of the City's police officers and sergeants does not ratify an agreement with the City calling for the pension changes set forth in Section 34.2 herein, the changes will not become effective for Lieutenants. In the event that the bargaining unit consisting of the City's police officers and sergeants ratifies an agreement with the City calling for pension changes other than those set forth in

Section 34.2 herein, the City shall have the right to immediately reopen this Agreement to negotiate pension changes with the PBA that are consistent with those agreed to by the bargaining unit consisting of the City's police officers and sergeants.

## **ARTICLE 35 - NO SMOKING POLICY**

All employees hired after March 23, 2009 shall certify in a form provided for by the City that they are non-smokers, have not smoked cigarettes for the past year and will not smoke cigarettes on or off-duty while employed with the City. If an employee hired after March 23, 2009 of this Agreement smokes on or off-duty, he/she will be terminated effective immediately. The employee only will have the right to grieve whether he/she smoked and shall not have the right to challenge the discipline imposed.

#### Except as otherwise provided in this Agreement, this Agreement will become effective upon ratification by both parties and shall remain in full force and effect through and including September 30, 2016.
